

## TERMS AND CONDITION (WONDALAND ZOOM PARTY)

### **AGREEMENT TO TERMS**

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and Double seis, DR Dolor Entertainment (“we,” “us” or “our”), concerning your access to watch the Wonderland VR Experience (video) by TENI THE ENTERTAINER.

You agree that by accessing the Wondaland Zoom Party(event), you have read, understood, and agree to be bound by all of these Terms and Conditions. #### Age requirements
